Secretarial Compliances: An Overview

Companies Act 2013 has significantly enhanced the disclosure requirement by companies and its Directors to Shareholders and various statutory authorities like registrar of companies, stock exchanges, etc. Additionally, multiple penal provisions had been introduced around imprisonment and significantly high monetary penalties.

Currently, the act requires 661+ compliances and 100+ filings applicable to various types of companies, and these rules and regulations are amended very frequently by the Ministry of Corporate Affairs (MCA).

All these requirements are complex and require in-depth understanding and expertise knowledge. Currently, these complex requirements are managed by Companies' Secretarial departments manually with no technological support mechanism.

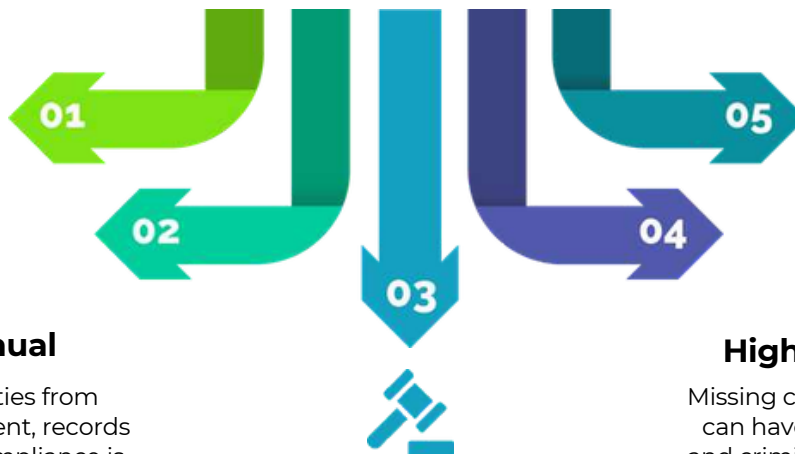

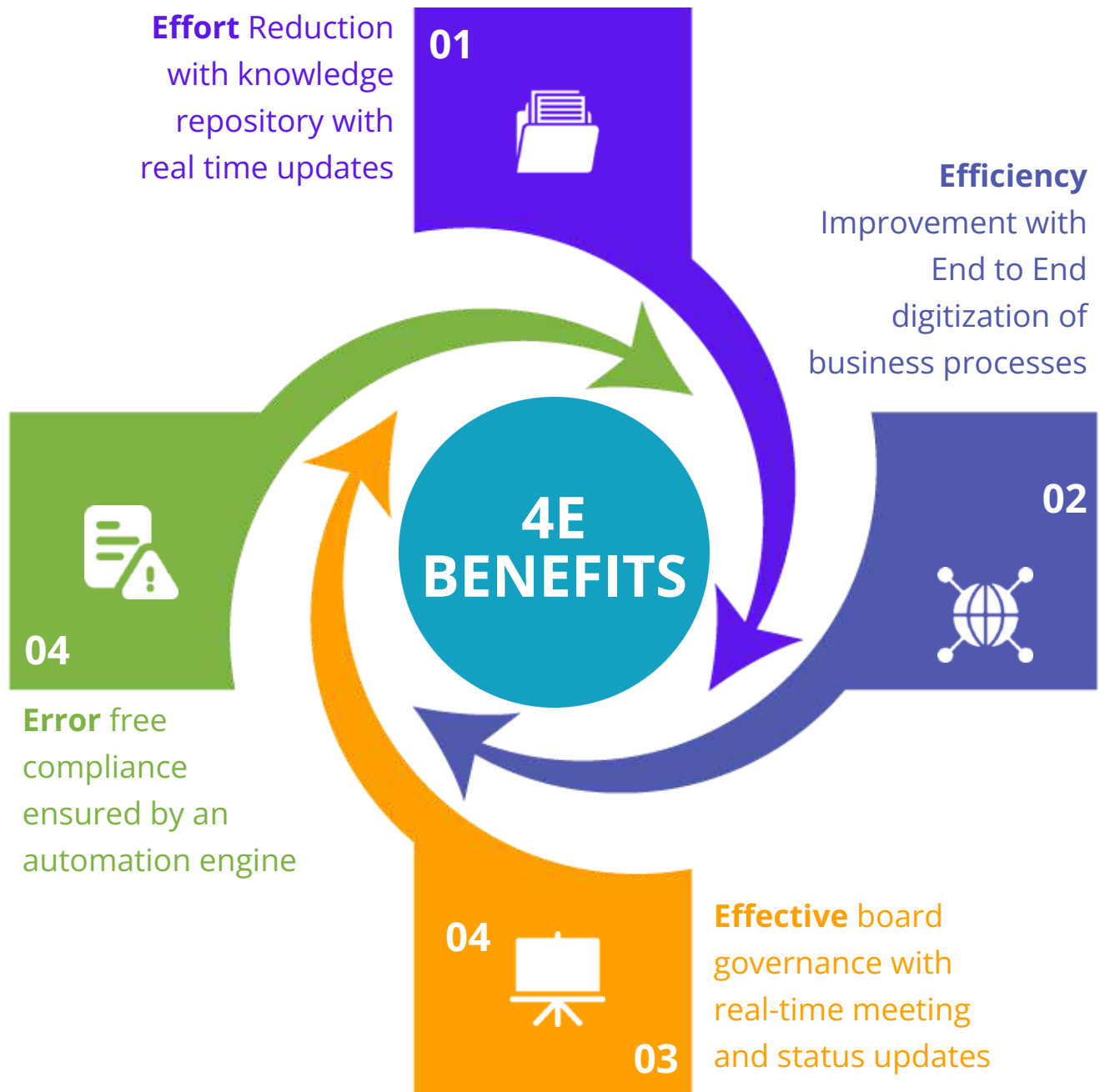
