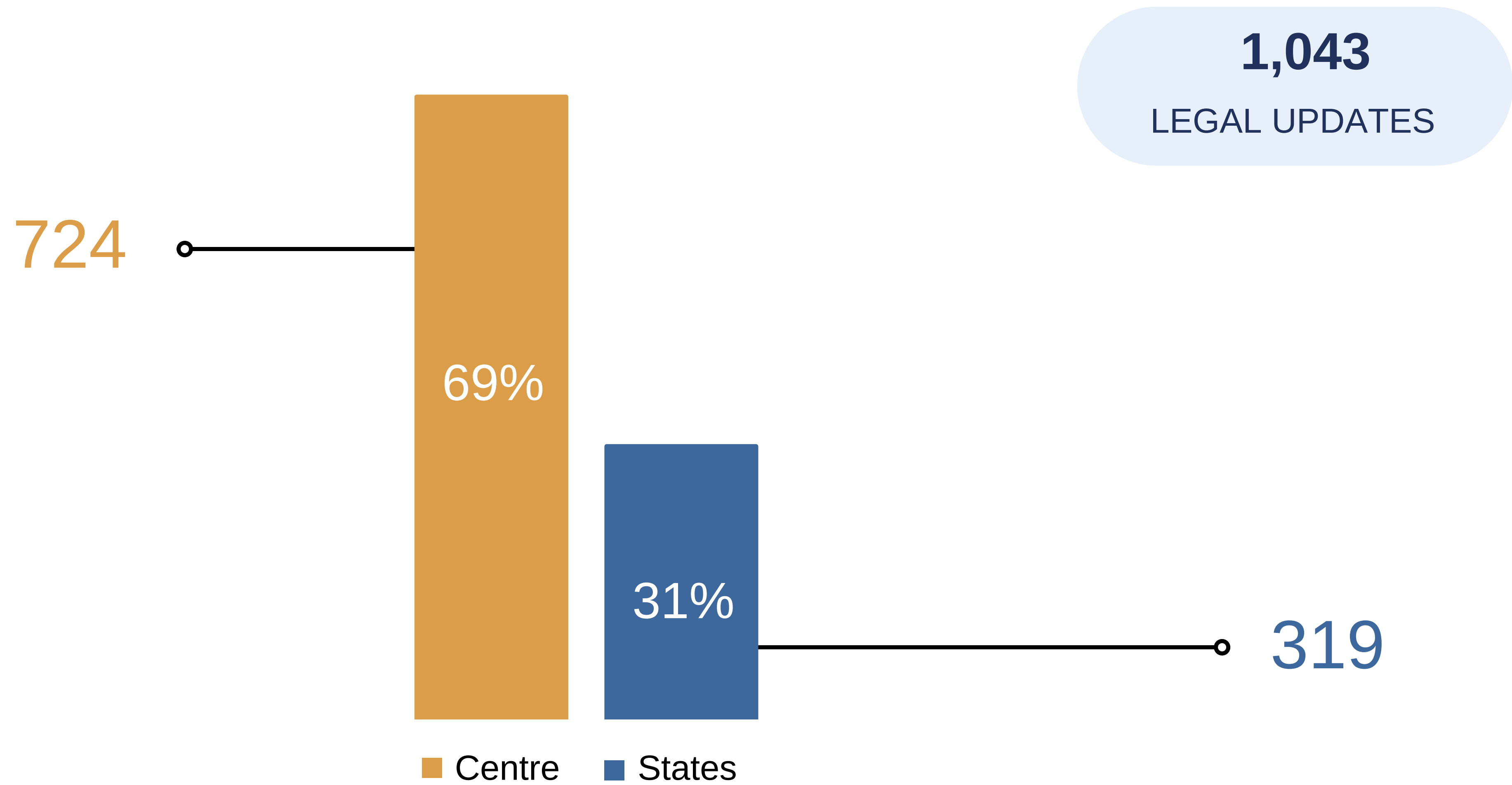
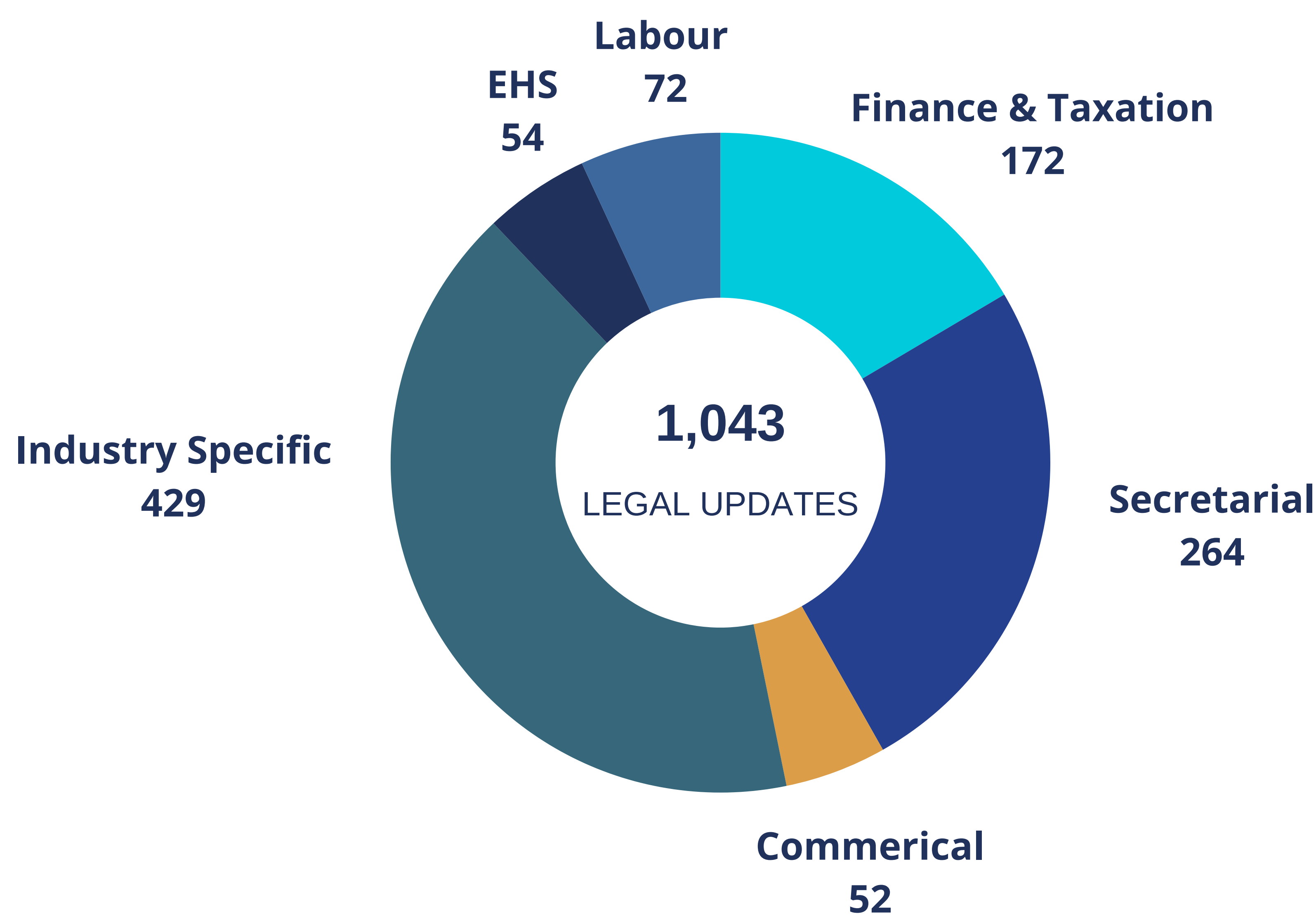

1 FINANCE AND TAXATION UPDATES

These bonds aim to channel climate finance into "hard-to-abate" industries such as steel, cement, and aviation that are often excluded from traditional green financing.
