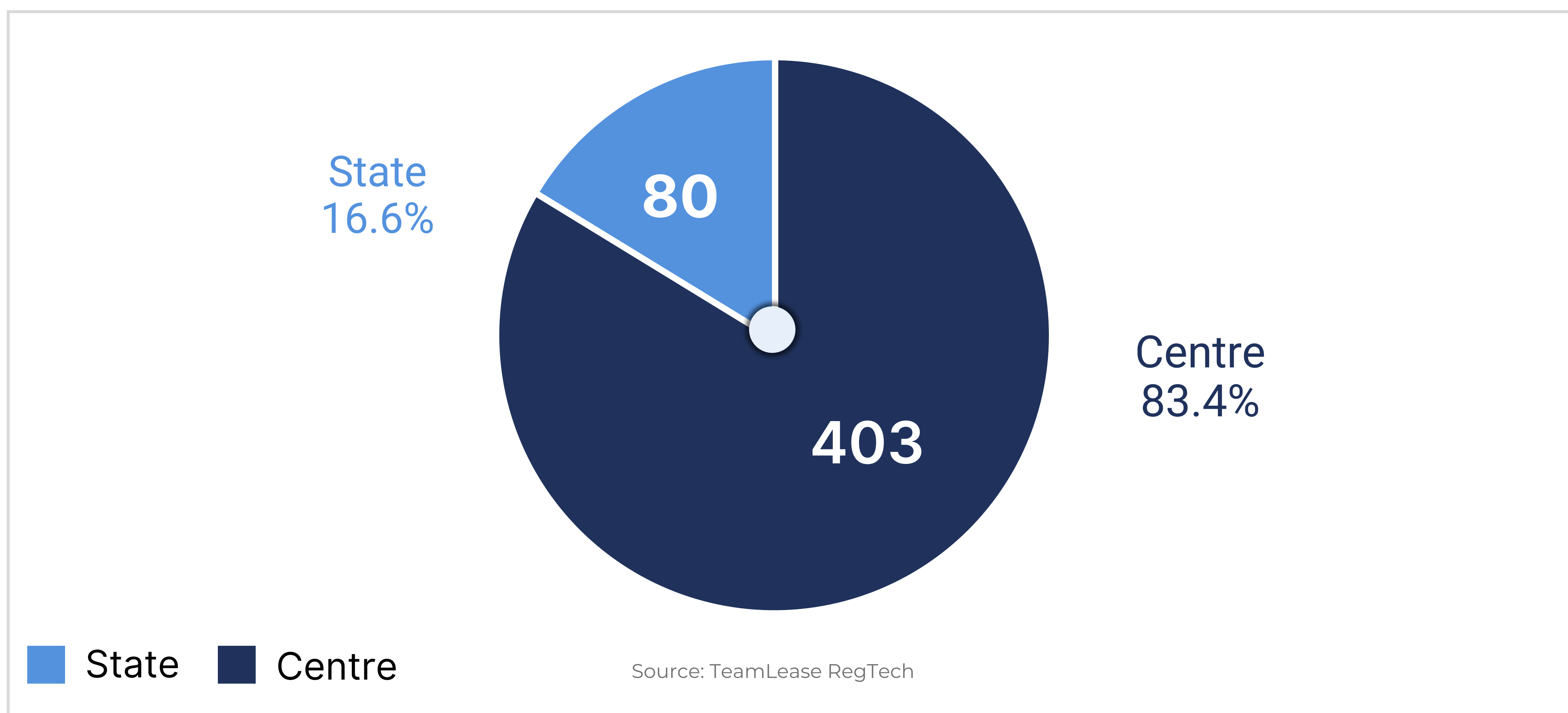

1 FINANCE AND TAXATION

There were 33 legal updates in this category

- The Goods and Services Tax Network (GSTN), on December 05, 2025, issued an advisory on reporting values in Table 3.2 of GSTR-3B.
- The Government of the National Capital Territory of Delhi (GNCTD), on December 01, 2025, issued a notification under section 54(6) of the Delhi Goods and Services Tax Act, 2017, specifying categories of registered persons who shall not be eligible for provisional refund of GST. The notification follows recommendations of the GST Council and aims to strengthen verification and risk-management measures in refund processing.
- The Reserve Bank of India (RBI) on December 02, 2025, issued instructions to banks to provide customer services in regional languages.
- The Lok Sabha on December 01, 2025, issued the Central Excise (Amendment) Bill, 2025, further to amend the Central Excise Act, 1944.
- The Reserve Bank of India (RBI) on November 28, 2025, notified the Foreign Exchange Management (Export and Import of Currency) (Amendment) Regulations, 2025, further to amend the Foreign Exchange Management (Export and Import of Currency) Regulations, 2015.

2 SECRETARIAL

There were 35 legal updates in this category

- The Securities and Exchange Board of India (SEBI) on December 03, 2025, issued the Securities and Exchange Board of India (Share Based Employee Benefits and Sweat Equity) (Second Amendment) Regulations, 2025, to further amend the Securities and Exchange Board of India (Share Based Employee Benefits and Sweat Equity) Regulations, 2021.
- The India International Exchange (IFSC) Ltd. (India INX) on December 03, 2025, notified regarding the commonly observed violations and indicative penalties.
- The National Commodity & Derivatives Exchange Limited (NCDEX), on December 03, 2025, announced the launch of a Liquidity Enhancement Scheme (LES) for Maize - Feed/Industrial Grade (Symbol: MAIZE) futures contracts. The initiative is issued pursuant to SEBI's Master Circular dated August 04, 2023, which provides the regulatory framework for introducing LES in the commodity derivatives segment.
- The NSE Clearing Limited (NCL), on December 03, 2025, issued a circular implementing the risk-management framework mandated under Point 5.6 of SEBI's circular dated May 29, 2025, relating to the introduction of a pre-open session for equity derivatives. This measure aims to enhance trading convenience while strengthening risk controls in the Futures & Options (F&O) segment across both single-stock and index derivatives.
- The Securities and Exchange Board of India (SEBI) on December 01, 2025, issued the Securities and Exchange Board of India (Foreign Venture Capital Investors) (Amendment) Regulations, 2025, further to amend the Securities and Exchange Board of India (Foreign Venture Capital Investors) Regulations, 2000.

3 COMMERCIAL

There were 14 legal updates in this category

- The Bureau of Indian Standards, on November 17, 2025, issued the date of withdrawal of certain Indian Standards.
- The Ministry of Information & Broadcasting (MIB) on November 26, 2025, issued the notification regarding inviting inputs in addressing copyright infringement and strengthen antipiracy strategies.
- The Ministry of Consumer Affairs, Food and Public Distribution (MoCAFPD), on December 02, 2025, issued the Legal Metrology (Packaged Commodities) Second Amendment Rules, 2025 under section 52 of the Legal Metrology Act, 2009. These amendments modify the regulatory framework governing declarations and requirements applicable to packaged commodities sold across India.
- The Directorate General of Foreign Trade (DGFT) on December 01, 2025, issued the amendments in Paras 4.87 (a) and 4.88 of the Handbook of Procedures 2023.
- The Ministry of Micro, Small and Medium Enterprises (MSME) on December 01, 2025, launched MSME TEAM Initiative to Strengthen Digital Commerce Integration.

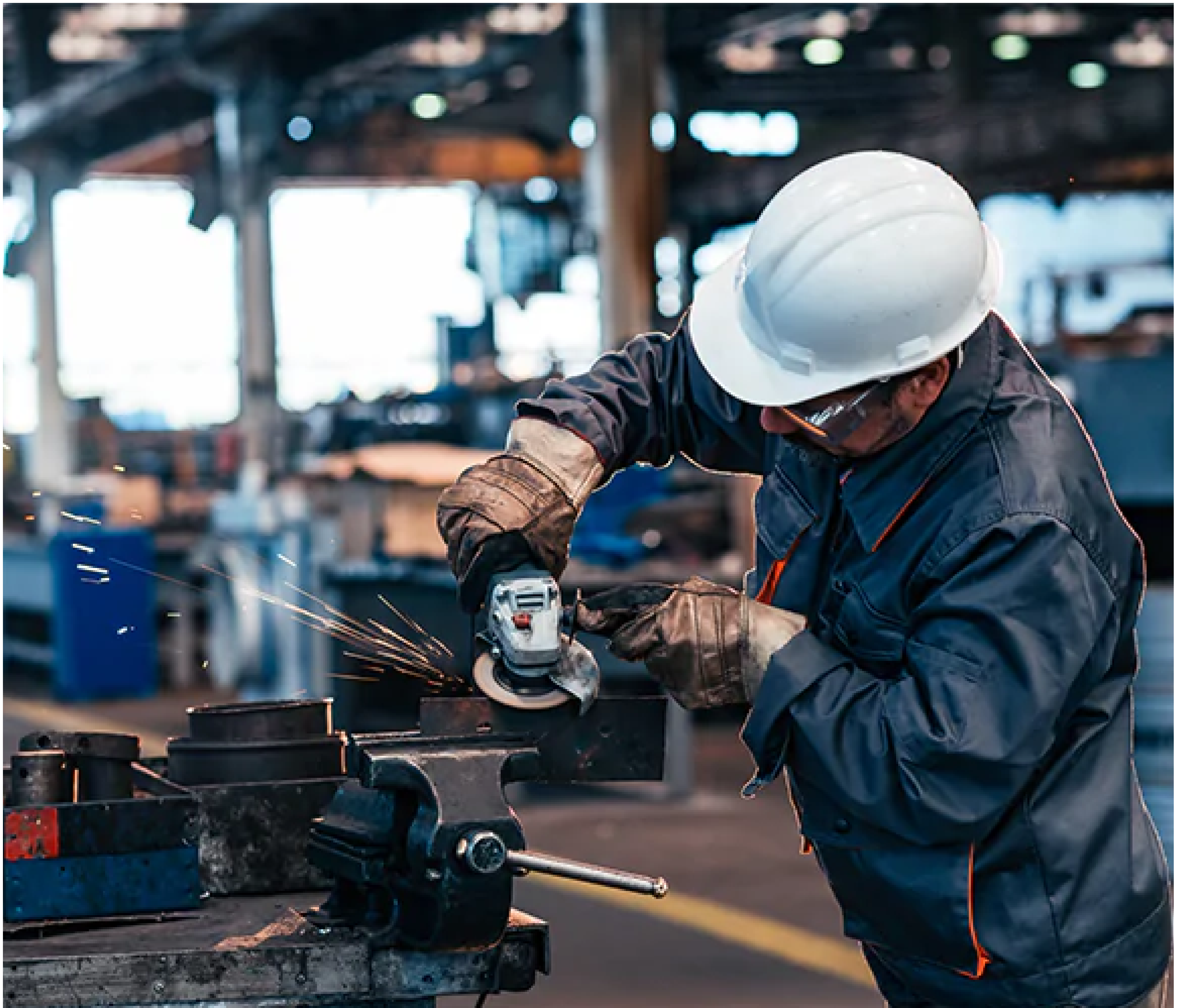


4 INDUSTRY SPECIFIC

There were 361 legal updates in this category

- The Ministry of Agriculture and Farmers Welfare (MoA&FW) on December 03, 2025, issued the Fertiliser (Inorganic, Organic or Mixed) (Control) Twelfth Amendment Order, 2025, further to amend the Fertiliser (Inorganic, Organic or Mixed) (Control) Order, 1985.
- The National Pharmaceutical Pricing Authority (NPPA) on December 01, 2025, issued the Computation of Retail Price of Paracetamol IP 250mg + Phenylephrine Hydrochloride IP 5.0 mg + Chlorpheniramine Maleate IP 2.0 mg Suspension for M/s Mascot Health Series Pvt. Ltd. (Manufacturer) & M/s Macleods Pharmaceuticals Ltd. (Marketer).
- The National Payments Corporation of India (NPCI) on December 01, 2025, notified regarding the implementing Daily Settlement for NFS & RuPay International Products on All Calendar Days.
- The Securities and Exchange Board of India (SEBI) on December 04, 2025, issued a consultation paper on the review of existing position limits for trading members in the equity derivatives segment.

5 ENVIRONMENT, HEALTH AND SAFETY

There were 15 legal updates in this category

- The Central Pollution Control Board (CPCB) on August 12, 2025, issued notification regarding ensuring adherence to the revised OCEMS protocols for calibration and alerts - regarding self-monitoring of Compliance.
- The Ministry of Commerce and Industry (MoCI) on October 22, 2025, issued the Boilers (Adjudication and Appeal) Rules, 2025 and in supersession of the Boiler (Inquiry, Adjudication and Appeal) Rules, 2024, except as respects things done or omitted to be done before such supersession.
- The Ministry of Road Transport & Highways (MoRT&H), on October 29, 2025, notified regarding the NHAI to Take Proactive Measures to Mitigate Air Pollution on Highways in Delhi-NCR.
- The Ministry of Environment, Forest and Climate Change (MoEF&CC) on October 22, 2025, issued an extension of the timeline for filing the returns under the Hazardous and Other Wastes (Management and Transboundary Movement) Second Amendment Rules, 2023 (EPR for Used Oil).

- The Employees' State Insurance Corporation (ESIC) on December 03, 2025, notified regarding the mandatory ESIC Registration for Educational Institutions under the Code on Social Security, 2020.
- The Ministry of Labour and Employment (MOLE) on December 04, 2025, notified regarding the social security measure for Gig and Platform workers.
- The Employees Provident Fund Organisation (EPFO) on December 01, 2025, notified regarding the discontinuation of Extension of Timeline for Mandatory Aadhaar Seeding with UAN for Filing of ECR in respect of Establishments in the North East Region and Certain Classes of Establishments.
- The PIB Headquarters, on December 01, 2025, notified regarding the Petroleum Industry Benefits with Improved Safeguards under New Labour Codes.
