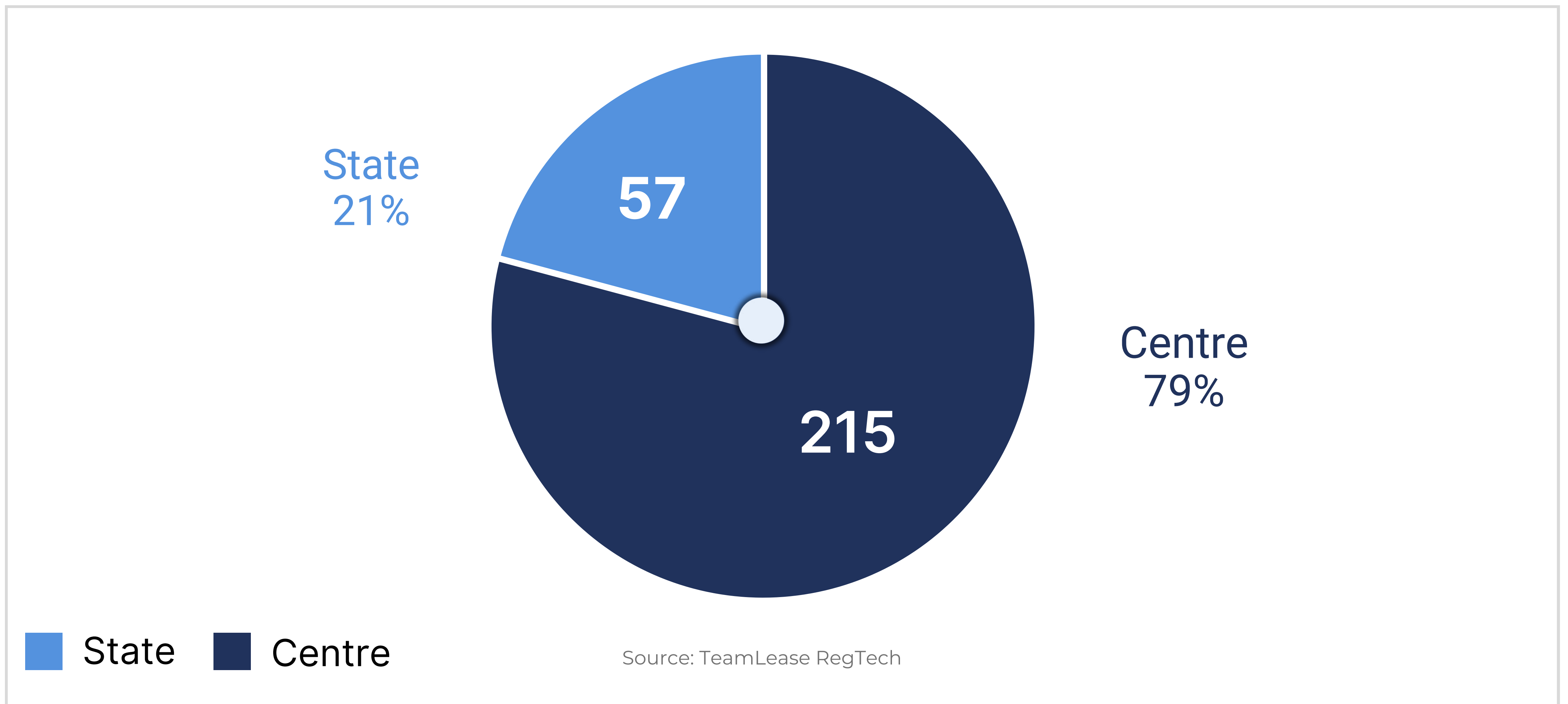

1 FINANCE AND TAXATION

There were 15 legal updates in this category

- The Central Board of Indirect Taxes and Customs (CBIC) on December 11, 2025, issued a notification regarding the amendment of the Customs Tariff Value.
- The Directorate General of Trade Remedies (DGFT) on December 05, 2025, issued corrigendum in the Anti-dumping investigation concerning imports of "certain antioxidants" originating in or exported from China PR and Singapore.
- The Ministry of Finance (MoF) on December 08, 2025, issued date of enforcement of Selected Provisions of the Banking Laws (Amendment) Act, 2025.
- The Goods and Services Tax (GST), on December 05, 2025, notified regarding the Auto Suspension of GST Registration due to Non-Furnishing of Bank Account Details as per Rule 10A.
- The Reserve Bank of India (RBI) on December 05, 2025, issued the Monetary Policy Statement, 2025-26 Resolution of the Monetary Policy Committee December 3 to 5, 2025.
- The Income Tax Department notified regarding the Applications for Rectification against TP/DRP/Revision Orders can now be filed directly before the Respective Authority through the E-Filing Portal under the Services Tab-> Rectification->Request to AO seeking rectification.

2 SECRETARIAL

There were 48 legal updates in this category

- The Bombay Stock Exchange (BSE) on December 12, 2025, issued a notification regarding Trading Holidays for the Calendar Year 2026 for Equity and Equity Derivatives Segments.
- The National Commodity & Derivatives Exchange Limited (NCDEX) on December 11, 2025, notified regarding the introduction of New Transaction Type -Rdg Transfer.
- The National Commodity Clearing Limited (NCCL) on December 11, 2025, issued a circular notifying the Final Settlement Prices (FSP) for Options on Futures contracts that expired on December 11, 2025. The settlement has been carried out in accordance with the procedures prescribed under Circular No. NCCL/CLEARING-033/2024 dated June 24, 2024 governing Options on Futures clearing and settlement.
- The National E-Governance Services Ltd. (NeSL) on December 12, 2025, issued a circular regarding the use of authorised representatives.
- The Ministry of Finance (MoF) on December 10, 2025, notified the Banking Regulation (Companies) Amendment Rules, 2025, further to amend the Banking Regulation (Companies) Rules, 1949.

3 COMMERCIAL

There were 19 legal updates in this category

- The Bureau of Indian Standards (BIS), on December 11, 2025, issued the date of the establishment and the date of withdrawal of Indian standards particulars related to Voltage.
- The Directorate General of Foreign Trade (DGFT) on December 11, 2025, issued a notification regarding amendments in Standard Input Output Norms (SION) A-290.
- The Central Government, on December 05, 2025, issued the Motor Vehicles (Amendment) Bill, 2025, to further amend the Motor Vehicles Act, 1988.
- The Central Government, on December 09, 2025, issued the Consumer Protection (Amendment) Bill, 2025, to further amend the Consumer Protection Act, 2019.
- The Lok Sabha on December 05, 2025, issued the Special Economic Zones (Amendment) Bill, 2024 further to amend the Special Economic Zones Act, 2005.

4 INDUSTRY SPECIFIC

There were 150 legal updates in this category

- The Bureau of Energy Efficiency (BEE) on December 01, 2025, issued the Corrigendum on Issue No. 561 dated August 11, 2025 regarding the "Bureau of Energy Efficiency (Certification of Energy Auditors, Energy Auditors (Building) and Energy Managers) Regulations, 2025"
- The Directorate General of Civil Aviation (DGCA), on December 09, 2025, issued a Draft amendment in Civil Aviation Requirements Section 2 - Airworthiness Series C Part I.
- The Central Depository Services (India) Limited (CDSL) on December 05, 2025, issued the notification regarding the Amendments to DP Operating Instructions Chapter - 12.
- The Lok Sabha on December 05, 2025, introduced the Mental Healthcare (Amendment) Bill, 2024 to further amend the Mental Healthcare Act, 2017.
- The Lok Sabha on December 08, 2025, proposed Insurance (Amendment) Bill, 2025. The Bill expands definitions in Section 2 by inserting new terms -"health insurance premium" and "senior citizen", with differentiated age thresholds (60 years for men and 58 years for women). These amendments seek to create a clearer statutory basis for regulating senior citizen health insurance products.
- The Ministry of Food Processing Industries (MoFPI), on December 12, 2025, issued the PLI Scheme for Food Processing Industry.

5 ENVIRONMENT, HEALTH AND SAFETY

There were 12 legal updates in this category

- The Delhi Pollution Control Committee (DPCC) on December 09, 2025, issued directions under Section 31A of the Air (Prevention and Control of Pollution) Act, 1981, to curb dust pollution arising from roadside storage, sale, and transportation of construction materials in Delhi. These directions follow persistent poor air quality levels and repeated interventions from the Hon'ble Supreme Court, NGT, and the Commission for Air Quality Management (CAQM).
- The Lok Sabha on December 05, 2025, introduced the Environment (Protection) Amendment Bill, 2025 to further amend the Environment (Protection) Act, 1986.
- The Central Pollution Control Board (CPCB) issued a notice on November 28, 2025, regarding the 'Removal of Difficulties' for the shortage of EPR certificates in the recycling categories of Cat II & Cat III, as well as the implementation of EPR Guidelines for Plastic Packaging.
- The Government of India, on December 03, 2025, issued the Reptile Bite (Prevention and Treatment) and Reptile Conservation Bill, 2025.

6 LABOUR

There were 28 legal updates in this category

- The Government of NCT of Delhi, on December 9, 2025, issued a notification under section 47 of the Delhi Shops & Establishments Act, 1954, announcing amendments to the Delhi Shops & Establishments Rules, 1954. The amendment follows the procedure of prior publication as mandated under the parent statute.
- The Lok Sabha on December 05, 2025, introduced the Protection and Welfare of Sanitation Workers Bill, 2024 to provide regulations for the protection, welfare, and rehabilitation of sanitation workers engaged in the maintenance of public and private spaces, including waste management, disinfection, and sanitization and for matters connected therewith or incidental thereto.
- The Rajya Sabha on December 05, 2025, issued the Child and Adolescent Labour (Prohibition and Regulation) (Amendment) Bill, 2024, further to amend the Child and Adolescent Labour (Prohibition and Regulation) Act, 1986.
- The Central Government, on December 05, 2025, issued the Reservation for the Other Backward Classes, the Scheduled Castes and the Scheduled Tribes in Private Sector Services and Appointments Bill, 2025.
- The Central Government, on December 05, 2025, issued the Representation of the People (Amendment) Bill, 2024, to further amend the Representation of the People Act, 1951.
