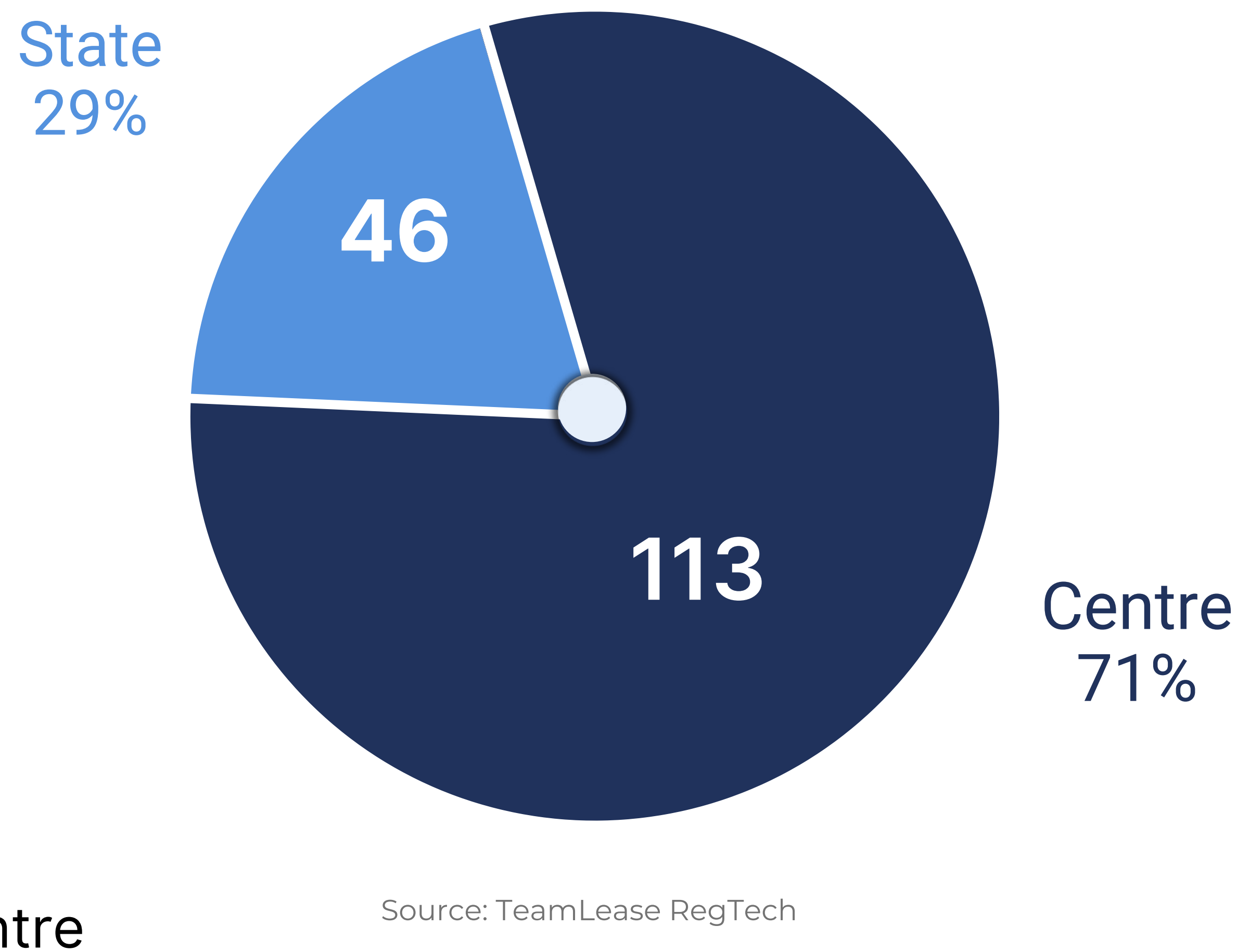

1 FINANCE AND TAXATION

There were 13 legal updates in this category

- The Reserve Bank of India (RBI), on July 30, 2026, issued the Reserve Bank of India (Small Finance Banks – Financial Statements: Presentation and Disclosures) Fourth Amendment Directions, 2026.
- The Ministry of Finance (MoF) on July 24, 2026, issued the Income-tax (Third Amendment) Rules, 2026, to further amend the Income-tax Rules, 2026.
- The Reserve Bank of India (RBI) on July 31, 2026, notified regarding the Lending and Deposit Rates of Scheduled Commercial Banks – July 2026.
- The Central Board of Indirect Taxes and Customs (CBIC), Department of Revenue, Ministry of Finance, on July 28, 2026, issued a corrigendum to Notification No. 28/2026-Customs dated July 10, 2026, to rectify an error in the English version of the notification published in the Official Gazette.
- The Central Board of Indirect Taxes and Customs (CBIC), on July 25, 2026, has clarified the procedure for filing departmental appeals before the Goods and Services Tax Appellate Tribunal (GSTAT) against appellate authority orders in cases where the original adjudication was carried out by a Common Adjudicating Authority (CAA) for DGGI investigations.

- The Ministry of Consumer Affairs, Food and Public Distribution (MoCAF&PD) on July 28, 2026, issued a notification regarding imposition of Sugar Stock Holding Limits for the month of August–November 2026.

- The Reserve Bank of India (RBI) on July 30, 2026, issued amendment Directions on Interest Rate on Deposits.
- The Central Drugs Standard Control Organisation (CDSCO) on July 13, 2026, issued a regulatory alert regarding the cancellation of Registration Certificates of Ethics Committees under the New Drugs and Clinical Trials Rules, 2019.
- The Rajya Sabha on July 28, 2026, issued the Micro, Small and Medium Enterprises Development (Amendment) Bill, 2026 to further amend the Micro, Small and Medium Enterprises Development Act, 2006.
