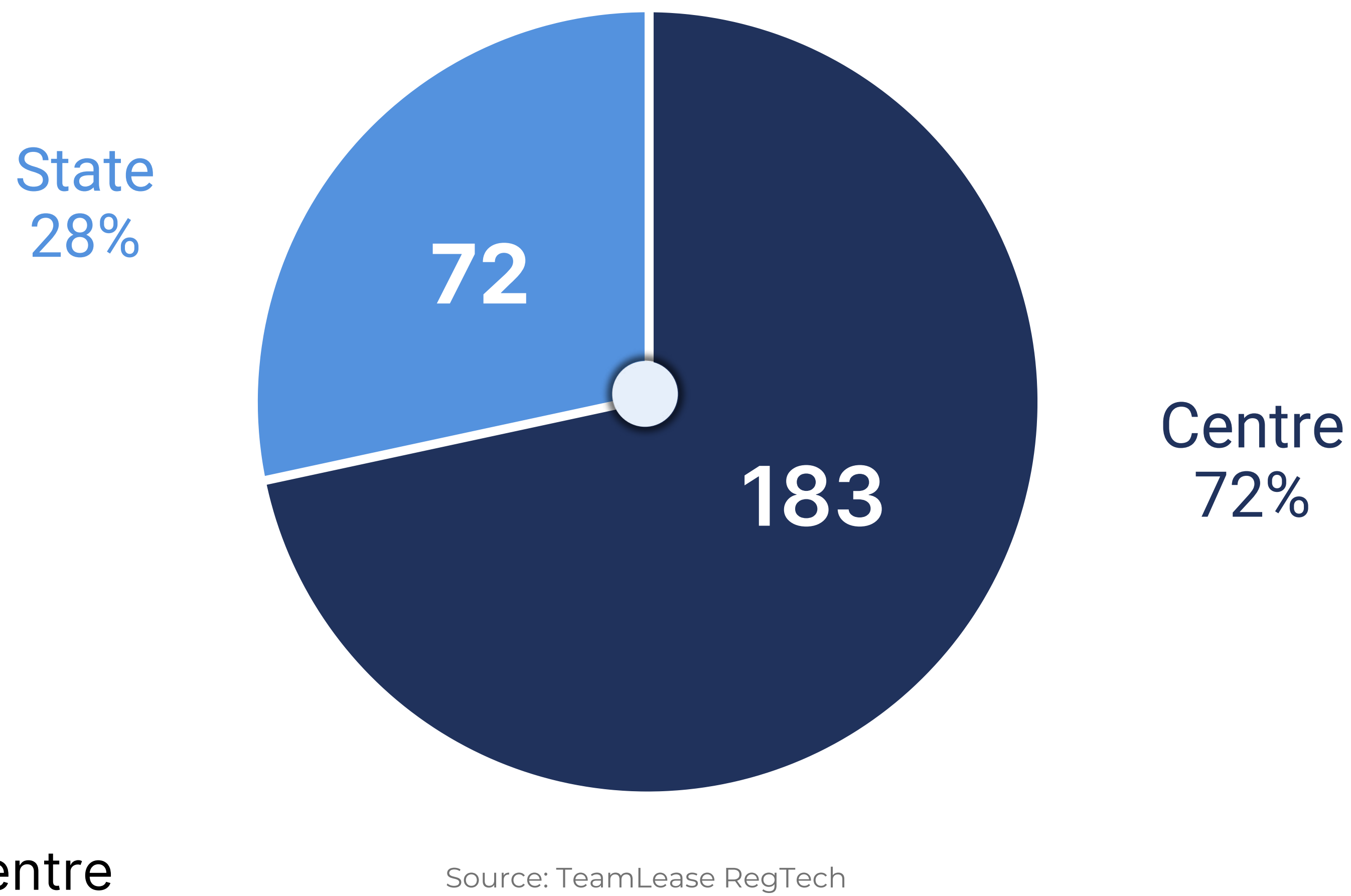

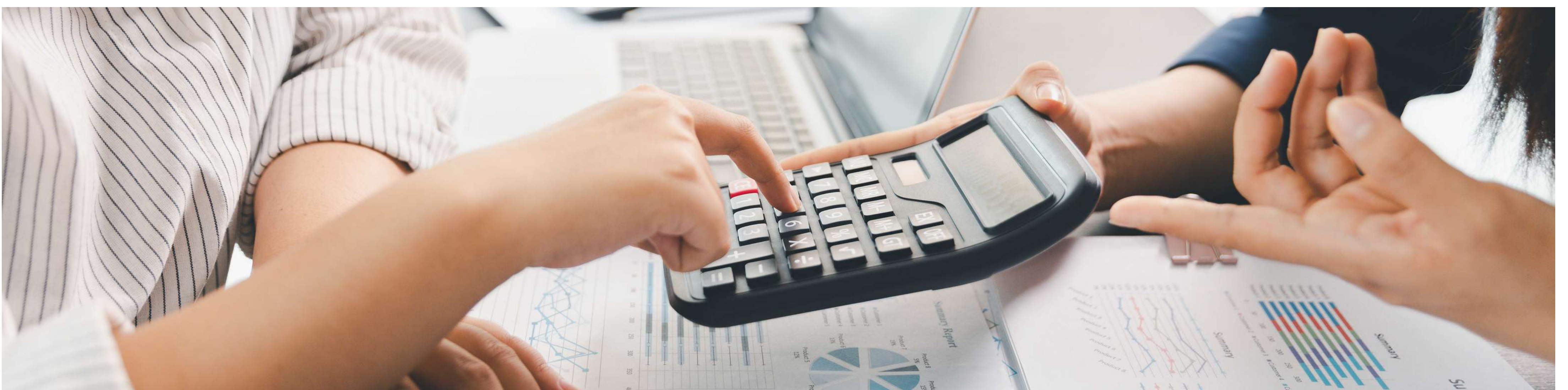


1 FINANCE AND TAXATION

There were 16 legal updates in this category

- The Ministry of Finance (MoF) on March 12, 2026, amended an older notification No. 45/2025-Customs, dated October 24, 2025, related to the customs exemption.
- The Ministry of Commerce and Industry (MoCI) on March 11, 2026, notified regarding the Initiation of an anti-dumping investigation concerning imports of "Phthalic Anhydride" from Taiwan.
- The Pension Fund Regulatory and Development Authority (PFRDA) on March 10, 2026, issued circular regarding the Charge structure of Point of Presence (PoP) for Common Schemes under NPS for Legal Entities (other than Government).
- The Reserve Bank of India (RBI) on March 09, 2026, notified regarding the Financial Action Task Force (FATF) High Risk and other monitored jurisdictions -February 09-13, 2026.
- The Ministry of Finance (MoF), on March 10, 2026, notified regarding the Levy of fee for the amendment or cancellation of export documents in cases of withdrawal of export consignments due to force majeure circumstances.

- The India International Exchange (IFSC) Limited (India INX) on March 13, 2026, issued circular regarding the Introduction of Bidding for IPOs through India INX iBBS Platform.
- The National Stock Exchange (NSE) on March 13, 2026, issued a circular regarding Mock trading on Saturday, March 14, 2026 - Revision of Order-to-Trade Ratio (OTR) framework - No new version release.
- The National Commodity Clearing Limited (NCCL) on March 12, 2026, issued a circular regarding the settlement Price of Options on Futures contract that expired.
- The Multi Commodity Exchange of India Ltd. (MCX) on March 13, 2026, notified regarding the Mock Trading Session on March 14, 2026.

There were 30 legal updates in this category

- The Bureau of Indian Standards (BIS) on March 12, 2026, issued the date of establishment and withdrawal of the Single-Ended Hegar's Pattern Uterine Dilators.
- The Ministry of Consumer Affairs, Food and Public Distribution (MCAFPD) on March 12, 2026 issued a notification amending the Legal Metrology (General) Rules, 2011 under the powers granted by the Legal Metrology Act, 2009. The amendment is titled the Legal Metrology (General) Third Amendment Rules, 2026.
- The Ministry of Micro, Small and Medium Enterprises (MSME) on March 12, 2026, reported progress in the implementation of the MSME Champions Scheme, which aims to promote competitiveness, quality enhancement and innovation among MSMEs. The ministry stated that key deliverables under the scheme have met or exceeded their targets, and an evaluation is currently underway to assess the impact of its various components.
- The Directorate General of Foreign Trade (DGFT) on March 06, 2026, notified regarding the launch of Credit Assistance for E-Commerce Exporters under Export Promotion Mission (EPM) - NIRYAT PROTSAHAN.

- The Central Pollution Control Board (CPCB) on March 09, 2026, issued an extension of the National Control Room for six months for effective implementation of the ban on identified single-use plastic items.
- The Ministry of Jal Shakti (MoJS), on notified regarding the cabinet approves extension of Jal Jeevan Mission (JJM) period up to December 2028 with enhanced outlay and restructured implementation focusing on structural reforms in rural drinking water supply sector under JJM 2.0.

- The Ministry of Skill Development and Entrepreneurship (MSDE) on February 18, 2026, issued an Office Memorandum regarding the implementation of a portal upgrade to address issues related to rebate in the apprenticeship training period.
