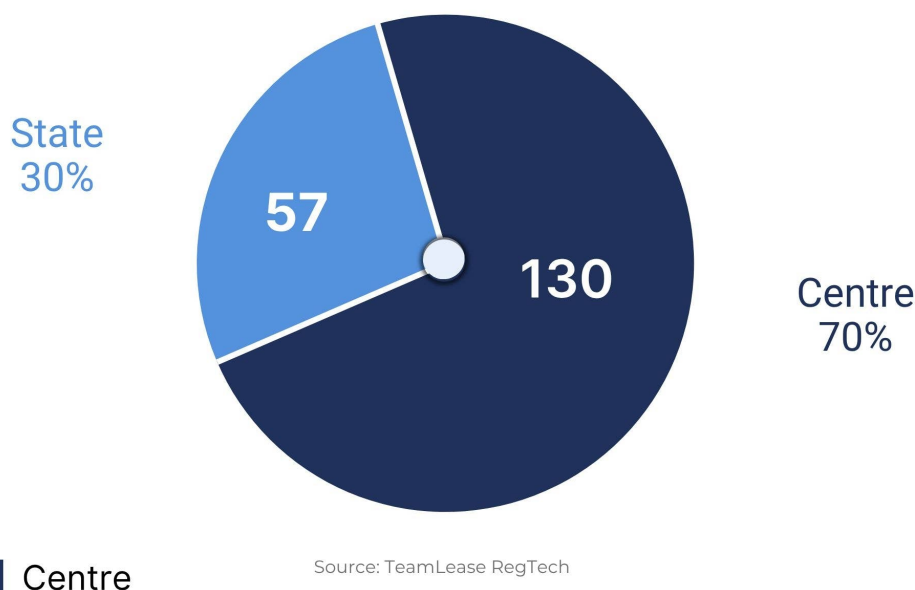

Total Legal Updates **187**



1 FINANCE AND TAXATION

There were 12 legal updates in this category.

- The Central Board of Direct Taxes (CBDT) on September 10, 2026, issued Format, Procedure and Guidelines for submission of Statement of Financial Transactions (SFT-2518) for Mutual Fund Transactions under section 508(1) of the Income-tax Act, 2025 read with sub-rule 6 of rule 237 of the Income-tax Rules, 2026 by Registrar and Share Transfer Agent.
- The Central Board of Indirect Taxes and Customs (CBIC), on September 15, 2026, has amended Notification No. 36/2001-Customs (N.T.) dated August 3, 2001, under Section 14(2) of the Customs Act, 1962, by substituting Table-1, Table-2 and Table-3 prescribing revised tariff values for specified imported goods.
- The Ministry of Finance (MoF) on September 16, 2026, issued an amendment to the earlier notification No. 06/2026-Central Excise, dated March 26, 2026, regarding SAED rates on petrol and diesel with export restriction.
- The Central Board of Indirect Taxes and Customs (CBIC) on September 16, 2026, seeks to amend an notification no. No. 08/2026-Central Excise, dated March 26, 2026 to revise the Special Additional Excise Duty (SAED) rate on exports of Aviation Turbine Fuel (ATF) outside India.
- The Ministry of Commerce and Industry (MoCI) on September 01, 2026, notified the Anti-absorption investigation of the anti-dumping duty imposed on imports of 'Glufosinate and its salts' originating in or exported from China PR.

2 SECRETARIAL

There were 39 legal updates in this category.

- The Bombay Stock Exchange (BSE), on September 16, 2026, has advised Trading Members to ensure compliance with various TRAI directions, guidelines and regulatory requirements, pursuant to communication received from SEBI.
- The Insolvency and Bankruptcy Board of India (IBBI) has issued a Discussion Paper proposing amendments to the Insolvency Resolution Process for Personal Guarantors to Corporate Debtors.
- The Securities and Exchange Board of India (SEBI) on September 11, 2026, issued the Consultation Paper on Applicability of IT and Cyber Security Framework of MIIIs to their Subsidiaries.
- The NSE IFSC Limited (NSE IFSC) has issued a User Manual for submission of the Annual Compliance Audit Report by Broker Dealers through the ENIT Portal. The manual is intended to provide guidance and step-by-step instructions for completing the submission process.
- The Securities and Exchange Board of India (SEBI) has issued a Consultation Paper on Measures to Strengthen Business Continuity Plan (BCP) and Disaster Recovery (DR) of Market Infrastructure Institutions (MIIs), seeking stakeholder feedback on proposed enhancements to the existing BCP/DR framework.

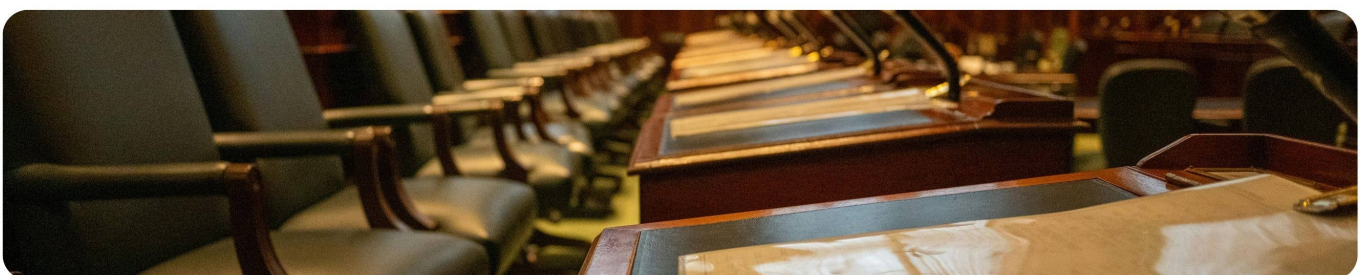

3 COMMERCIAL

There were 13 legal updates in this category.

- The Ministry of Consumer Affairs, Food and Public Distribution (MoCAFPD) on September 09, 2026, issued the Consumer Protection (E-Commerce) (Amendment) Rules, 2026 to further amend the Consumer Protection (E-Commerce) Rules, 2020.
- The Ministry of Defence (MoD) has published the Draft Lansdowne Cantonment Building Bye-Laws, 2026 under Section 251 of the Cantonments Act, 2006. The draft is proposed to supersede the earlier notification dated December 21, 1946, and is intended to regulate building and development activities within the limits of Lansdowne Cantonment.
- The Ministry of Road Transport and Highways (MORTH), on September 3, 2026, has issued draft rules to further amend the Central Motor Vehicles Rules, 1989, under Section 110 of the Motor Vehicles Act, 1988.
- The Bureau of Indian Standards (BIS), on September 1, 2026, has notified the establishment of six revised/new Indian Standards, with the standards established with effect from August 28, 2026, pursuant to Rule 15(1) of the Bureau of Indian Standards Rules, 2018.
- The Bureau of Indian Standards (BIS) on September 09, 2026, issued the date of establishment and withdrawal of the Planning and Design of Ports and Harbours and other Indian Standards.

4 INDUSTRY SPECIFIC

There were 101 legal updates in this category.

- The Ministry of Health and Family Welfare (MoHFW) on September 09, 2026, issued the Draft Drugs (Amendment) Rules, 2026 to further amend the Drugs Rules, 1945.
- The Ministry Of Coal (MoC) on September 09, 2026, issued the Coal Blocks Allocation (Second Amendment) Rules, 2026 to further amend the Coal Blocks Allocation Rules, 2017.
- The Central Electricity Authority (CEA) on September 07, 2026, issued the Draft Central Electricity Authority (Technical Standards for Construction of Electric Plants and Electric Lines) 2nd Amendment Regulations, 2026.
- The Ministry of Coal, on September 09, 2026, issued the Mineral Concession (Second Amendment) Rules, 2026, to further amend the Mineral Concession Rules, 1960
- The Reserve Bank of India (RBI) on September 18, 2026, issued the Reserve Bank of India (Commercial Banks - Know Your Customer) Amendment Directions, 2026.

5 ENVIRONMENT, HEALTH AND SAFETY

There were 10 legal updates in this category.

- The Ministry of Environment, Forest & Climate Change (MoEF&CC) on September 08, 2026, issued the Draft Commission for Air Quality Management in National Capital Region and Adjoining Areas (Imposition, Collection and Utilization of Environmental Compensation for Stubble Burning) Rules, 2026.
- The Central Pollution Control Board (CPCB) on September 08, 2026, issued the clarification regarding the distinction between Biodegradable and Compostable Plastics.

6 LABOUR

There were 12 legal updates in this category.

- The Ministry of Labour & Employment (MoLE), on September 16, 2026, announced that the Union Cabinet has approved enhancement of the wage ceiling for mandatory EPFO coverage from ₹15,000 to ₹25,000 per month. The decision is expected to bring more than 51 lakh additional employees within mandatory EPFO coverage, thereby expanding access to statutory social security.
- The Employees' State Insurance Corporation (ESIC) on September 14, 2026, issued the Directions for Improving File Disposal and Accountability.
- The Ministry of Labour and Employment (MoLE), on September 10, 2026, has issued a Corrigendum to the notification dated June 29, 2026, through which the Employees' Deposit-Linked Insurance Scheme, 2026 was notified.
